- E. Prevents inhaling infectious aerosols and other particles and contamination of the nose and mouth- Respirator with a particulate filter
- F. Prevents hand contamination and the spread of infection - Gloves
- G. It provides sun protection to the head, ears, face, and neck when working outside- Broad-brimmed hat
- H. Prevents contamination of the skin and protects personal clothing Disposable gowns/ overalls

Wet hands with water.	1
Rinse hands with water.	9
The process is complete.	12
Rub your hands palm to palm.	3
Use a towel to turn off the faucet [tap].	11
Rub your palms together, interlacing fingers.	5
Rotate thumbs clasped in one hand and repeat.	7
Dry hands thoroughly with a disposable paper towel.	10
Apply enough soap to cover the entire surface of your hands.	2
Rub clasped fingers back and forth on the palms of your hands and repeat.	8
Rub the backs of your fingers with opposing palms and fingers interlocked.	6
Place one palm on top of the back of your other hand and interlace your fingers, rubbing the soap between them and swap your hands to repeat the same step on the other hand.	4
